## XII. REGULAR AGENDA

- A. Mr. Rothermel made a motion as required by Texas Education Code 12A.005(b), the Board of Trustees approve the District of Innovation Plan as presented by the DOI Plan Committee and approved by DEIC, giving Santa Fe ISD the designation of District of Innovation, effective today, and to be in effect for up to 5 years. Mr. Snider seconded and all voted in favor.

- C. Mr. Snider made a motion to approve the purchase of 11 laptop carts at a cost not to exceed \$70,031.00. Mr. Rothermel seconded and all voted in favor.
- D. Mr. Snider made the motion to proclaim May 5, 2017 as School Lunch Hero Day in Santa Fe ISD. Mr. Rothermel seconded and all voted in favor.
- E. Mr. Davenport made the motion to resolve the week of May 6-12, 2017, as Nurse Appreciation Week in Santa Fe ISD. Mr. Rothermel seconded and all voted in favor.
- F. Mr. Rothermel made a motion to proclaim May 8-12, 2017 as Teacher Appreciation Week in Santa Fe ISD. Mrs. Skufca seconded and all voted in favor.
- G. Mr. Snider made a motion to proclaim May 11-17, 2017 as National Police Week in Santa Fe ISD. Mr. Rothermel seconded and all voted in favor.
- H. Mr. Davenport made a motion to proclaim May 10, 2017 as Paraprofessional Day in Santa

Fe ISD. Mr. Snider seconded and all voted in favor.

- I. Mr. Davenport made a motion to approve participation in a New Fuel Pool Agreement with TASB Energy Cooperative from May 1, 2017 to June 30, 2018. Mr. Rothermel seconded and all voted in favor.
- J. Mrs. Skufca made a motion to approve the one year renewal from July 1, 2017 to June 30, 2018 of the RediMD Health Services for all district employees. The district's cost of the service is \$1.50 per month per employee (based on no more than 610 employees) with the amount not to exceed \$10,980.00. Mr. Snider seconded and all voted in favor.
- K. Mr. Snider made a motion to approve the purchase of 4 HVAC units for the Jr. High School from Lennox for a price not to exceed \$71,532.00. Mr. Rothermel seconded and all voted in favor.
- L. Mrs. Skufca made a motion to approve the agreement to lease a portable building for R.J. Wollam for a cost not to exceed \$64,612 for 2017, with the total costs over two years not to exceed \$98,771. Mr. Rothermel seconded and all voted in favor.
- M. Mr. Snider made a motion to approve the contract with C.L. Davis & Co., for topographical and boundary survey services for a price not to exceed \$44,200. Mr. Rothermel seconded and all voted in favor.
- N. Mr. Snider made a motion to approve the contract with Terracon to provide an environmental site assessment and geotechnical investigation on the contracted property for a price not to exceed \$7,600.00. Mr. Rothermel seconded and all voted in favor.
- O. Mr. Snider made the motion to approve replacement of the wired infrastructure, the reimbursable E-Rate portion of \$364,722.95 and the SFISD portion is \$374,700.08 for a total cost not to exceed \$739,423.03. Mrs. Skufca seconded and all voted in favor.
- P. Mr. Snider made a motion to approve the donation from Texas Department of Criminal Justice for 60 desktop computers and monitors and 50 laptop computers to be used as part of the district's computer refresh and upgrades. Mr. Davenport seconded and all voted in favor.
